Attached is a link to State Representative Darlene Senger's resolution on the CN/EJE issue. **HR68 encourages and supports action by the 111th Congress of the United States to enact legislation to update Surface Transportation Board (STB) standards and criteria for approval of railroad merger applications to equally weigh the public interest of residents and communities with the benefits to commerce.** It is up for consideration today in the Rail Committee in Springfield.
