The Ela Twp notices will be mailed next Thurs, Nov 3rd. I have asked the county to release the values online early so people can get started now with reviewing their assessment. The 2011 assessments have been completed and most properties in Ela Township received a decrease, some substantial. The new values will be mailed/published November 3rd, but I have asked the County to publish the new values online early so that you can contact our office now.

Go to www.lakecountyil.gov/assessor <<http://www.lakecountyil.gov/assessor>> and select Property Tax Assessment Information under the Assessment Information tab on the left of the page. Enter your property information and you should see your new 2011 assessment.

If you feel the value is overstated you can submit an appraisal, information on your recent purchase, or comparable properties for our review.

We enjoy working with homeowners directly to help resolve their concerns and want to ensure you that you don't need to pay an attorney or tax representative to review your assessment.
