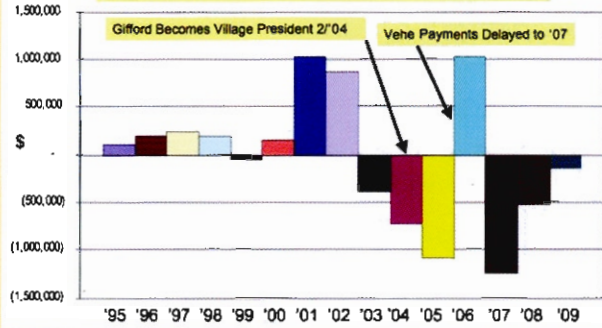

FISCAL RESPONSIBILITY

Net Change in Cash Balance from '95; Beginning '01,
Village revenues more than doubled to \$3M yet deficit
increased!



- Why has Village cash balance declined from \$3.4 million when Scott Gifford became president (February 2004) to \$1.6 million as of January 31, 2009?
- Why did Vehe Barn renovation cost over twice as much as initial contract?
- Why did the Village fund less than 30% of suggested road improvements over last five years?
- Where did \$60,000 for a lobbyist come from? Was this budgeted?
- Will President Obama bail out Deer Park?
